The Fund seeks to provide long-term growth of capital by investing in a global portfolio of high-quality companies which will grow in value over time.

The Fund aims to deliver long term capital growth by Investing in a diversified portfolio substantially consisting of equities listed on international stock exchanges. The Fund will be actively managed and the MSCI World Index will only be used for performance comparison purposes..

The Fund seeks investments whose price will increase over the long term. The Fund normally invests at least 80% of the Fund's total assets in equity and equity-related securities of companies. Equity-related securities in which the Fund primarily invests are common stocks, nonconvertible preferred stocks and convertible securities. The remainder of the Fund's portfolio may be invested cash, cash equivalents, deposits, money market instruments, government and public securities (such as sovereign debt and T-Bills).

The Investment Advisor aims to construct a portfolio of high-quality companies which will grow in value over time. The portfolio construction is influenced by identifying companies that have sustainably high levels of recurring revenues and strong profitability leading to above average profit margins. The Investment Advisor selects investments that it believes have above average long-term earnings, cash flow growth prospects and attractive valuation.

The Fund may invest in forward foreign currency exchange contracts, foreign currency swaps and exchange-traded derivatives, for hedging purposes and efficient portfolio management.


Intended Retail Investor:

The Fund is offered to investors who may have basic or no knowledge and experience of investing in financial markets and also experienced investors. The Fund is intended for long-term investment, in line with the recommended holding period or longer. Investors should understand the risks involved, including the risk of losing capital invested and must evaluate the Fund's objective and risks in terms of whether they are consistent with their own investment goals and risk tolerances.

What are the risks and what could I get in return?

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

Recommended holding period:	7 Years	

This product has no required minimum holding period but is designed for long-term investment. Since the value of investments can rise and fall over differing time periods, you should have an investment horizon of at least 7 years when buying an investment of this type. The minimum recommended holding period is therefore 7 years. You can request to take out some or all of your money at any time.
