The Fund seeks to provide long-term growth of capital by investing in a global portfolio of securities that are trading at a discount to their perceived intrinsic value. The Fund aims to deliver long term capital growth by Investing in a diversified portfolio substantially consisting of equities listed on international stock exchanges. The Fund will be actively managed and the MSCI World Index will only be used for performance comparison purposes.

The Fund seeks investments whose price will increase over the long term. The Fund normally invests at least 80% of the Fund's total assets in equity, equity-linked securities of companies, such as notes or preferred stock and equity-related securities such as, depositary receipts, nonconvertible preferred stocks and convertible securities. The remainder of the Fund's portfolio may be invested cash, cash equivalents, deposits, money market instruments, government, and public securities (such as sovereign debt and T-Bills).

The Fund seeks to invest in stocks whose prospects are misunderstood or not fully recognized by the market. The Fund employs a fundamental value investing approach which seeks to exploit market inefficiencies created by investor behaviour. Investors often overlook long-term fundamentals which drives stock prices in the long run. To identify these investment opportunities, the Fund employs a disciplined, bottom-up investment process highlighted by rigorous, internally generated fundamental research.

Although careful attention is paid to diversification and the risk associated with concentrated exposures, the portfolio is managed without reference to sector or stock weightings of an index. The Fund may invest in forward foreign currency exchange contracts, foreign currency swaps and exchange-traded derivatives, for hedging purposes and efficient portfolio management.

### **Intended Retail Investor:**

The Fund is offered to investors who may have basic or no knowledge and experience of investing in financial markets and also experienced investors. The Fund is intended for long-term investment, in line with the recommended holding period or longer. # What are the risks and what could I get in return?

Recommended holding period:	7 Years

This product has no required minimum holding period but is designed for long-term investment. Since the value of investments can rise and fall over differing time periods, you should have an investment horizon of at least 7 years when buying an investment of this type. The minimum recommended holding period is therefore 7 years. You can request to take out some or all of your money at any time. You can typically request to buy or sell shares in the Fund on any business day (as set out in the Fund's prospectus).
